MEDIA STATEMENT

IMPLEMENTATION OF THE EMPLOYMENT RELAXATION PLAN FOR FOREIGN WORKERS

1. The Ministry of Human Resources has announced the implementation of the Employment Relaxation Plan of Foreign Workers to speed up the application process and employment approval for hiring of foreign workers in critical sectors. Under this plan, the program will be implemented for the sectors / sub-sectors as follows:

- I. **Manufacturing**
- II. **Construction**
- III. **Farming**
- IV. **Agriculture**
- V. **Service (for restaurants only)**

2. Employers under the five sectors / sub-sectors mentioned above can **submit an application for the employment of foreign workers through the Foreign Worker Centralized Management System (FWCMS) platform under Module FWe Approval effective immediately**. HRM will process and give approval for foreign employment workers **in a period of three (3) working days from the date the application is received**. **Advertising vacancies on the MyFutureJobs are strictly excluded with immediate effect**.

3. Employers who have applied for the employment of foreign workers in the Module FWe Approval and Module eQuota before **17 January 2023** are required to re-submit a new application in the FWe Approval Module to allow the employer's application to be considered under the Employment Relaxation Plan of Foreign Workers.

PELAKSANAAN PELAN KELONGGARAN PENGGAJIAN PEKERJA ASING

1. Kerajaan telah mengumumkan pelaksanaan Pelan Kelonggaran Penggajian Pekerja Asing bagi menyegerakan proses permohonan serta kelulusan penggajian pekerja asing di sektor-sektor kritikal. Dalam hubungan ini, pihak KSM ingin memaklumkan bahawa pelaksanaan program ini akan dilaksanakan bagi sektor / sub sektor kritikal seperti berikut:
 - i. **Perkilangan**
 - ii. **Pembinaan**
 - iii. **Perladangan**
 - iv. **Pertanian**
 - v. **Perkhidmatan (Restoran sahaja).**
2. Majikan di bawah kelima-lima sektor/sub sektor yang dinyatakan di atas boleh mengemukakan permohonan penggajian pekerja asing melalui platform ***Foreign Worker Centralised Management System (FWCMS)*** di bawah Modul ***FWe Approval*** berkuat kuasa serta merta. KSM akan memproses dan memberikan kelulusan permohonan penggajian pekerja asing ini **dalam tempoh tiga (3) hari bekerja** daripada tarikh permohonan diterima. Pengiklanan kekosongan jawatan di Portal ***MyFutureJobs*** adalah dikecualikan berkuat kuasa serta merta.
3. Majikan yang telah membuat permohonan penggajian pekerja asing dalam Modul ***FWe Approval*** dan Modul ***eQuota*** sebelum **17 Januari 2023** dimohon untuk mengemukakan semula permohonan baharu di dalam di Modul ***FWe Approval*** bagi membolehkan permohonan majikan dipertimbangkan di bawah Pelan Kelonggaran Penggajian Pekerja Asing ini.
